**Minutes:**

**Financial Report:**

Finance Assistant Barrett distributed and discussed the July 2018 Operating Statement and the August 2018 Accrued Operating Statement.

The Purchased Power Adjustment for September 2018 remains at .027 cents per Kwh for all customers.

Manager of Technical Operations Coleman and Manager of Distribution Jackson made a detailed presentation prioritizing infrastructure replacements.

**General Managers Report:**

**Wilkins:**

Ascentech draft report was received today. Kowalik, Coleman and Ravagno will review with resolution to follow.

Agreed to contract with Tighe and Bond to assist in filing all required reports for all EPA, ISO and DEP reports for the coming year not to exceed \$19,000.

### **80 Commercial street Renovation:**

A couple GVW proposed change orders were completed by the Town and MMLD including, rainwater drainage on Commercial St and Hamond Park restoration. Waiting for quote on granite curbs and bricks for the walkways for Hamond Park.. The rainwater drainage at basement door area and the North wall drainage outside the substation are to be determined.

Remaining work to be completed by GVW as follows: Exterior pointing and waterproofing, substation A/C, basement dehumidification, linemen sink in garage, snow guards, gutter extensions and miscellaneous painting.

LED Street Light Program has been completed by the linemen.

### **Lead Mills:**
