It was moved by Commissioner Tumulty and seconded by Commissioner Kowalik to

approve the minutes of the September 14, 2016 meeting. **Unanimous** 

**Financial Reports:** 

Finance Manager Dugan distributed to and discussed with the Commission the July 2016

actual operating statement and the August accrued operating statement.

The Purchased Power Adjustment for September 2016 remains at .14 cents per Kwh for

all customers.

The Commissioners discussed the customer deposit policy for tenants. Currently, tenants must deposit \$200.00, which is held in the consumer deposit cash account until the tenant moves out at which time the \$200.00 credit is applied to their final bill.

Vote: #2016 - 49

It was moved by Commissioner Kowalik and seconded by Commissioner Tumulty to credit the tenant's bill for the \$200.00 initial deposit, succeeding the tenant making 24 consecutive payments before the due date. **Unanimous** 

Manager's Report:

Peaker provided Hadden with a detailed plan and timeframe with the expectation to meet 100% of the contract's specifications. The new solution will take about 6 weeks to fabricate, which involves replacing the existing exhaust stack with a modified stack, loaded with sound attenuation pack material and a directional elbow on the top of the muffler stack directed away from the sound area of concern.

**Vote: #2016 – 50** 

It was moved by Commissioner Kowalik and seconded by Commissioner Tumulty to make a payment to Peaker for 33% of the total contract. **Unanimous** 

Hadden informed the Commission that building renovation bid will be advertised on October 13, 2016. The garage at 80 commercial will require a three phase temp for heat during the renovation process.
