- Maximum rebate is 50% of the purchase price of each item
- Light department reserves the right to end these rebates at any time
- Must be purchased 1/1/2023 and 12/31/2023
- Applications must be postmarked by 1/31/2024 and mailed to the address above
- Do not mail with your utility payment
- If multiple tools purchased in a bundle, use 1 form per bundle; check all tools in bundle
